<p>Welcome and Introductions</p>	<p>The Health and Built Environment Committee of the Consortium for a Healthier Miami-Dade meeting was brought to order at 10:03 a.m. by Barbara Martinez-Guerrero.</p>	
<p>Approval of Minutes</p>	<p>There was a motion to approve the July 2024 Health and the Built Environment meeting minutes by Barbara Martinez-Guerrero and Second by Joanna Lombard.</p>	
<p>Executive Board Update</p>	<p>The Executive Board updates were provided by Barbara Martinez-Guerrero. The Executive Board last met virtual on Monday, August 12, 2024, and in person September 9, 2024.</p> <p>The Board focused on food insecurity and The Mayor’s Initiative on the Food and Nutrition For All Collaborative. There was a stakeholder meeting on Friday June 28<sup>th</sup> at Miami-Dade Downtown library. The collaborative was established to focus their efforts towards including policy and procedures, funding, nutrition guidelines, and food pantries and distributions, making part of their phase one, which would transition to phase two, which includes engagement letters to be sent out once phase one is complete.</p> <p>The Board continues the conversation on optimal health and addressing the root causes of environmental, social, and economic conditions that impact health.</p>	

	<p>Candice was able to attend the NACCHO 360 conference that took place in July in Detroit, MI; the theme of this conference was “Heard it Through the Great Vine: Public Health Collaboration and Innovation.” Candice Schottenloher and Islamiyat Nancy Adebisi, both attended the Florida Public Health Association Conference in Orlando, the theme was “Public Health Unbound; Here, There, Everywhere.” They presented on Mobilizing the Private Sector, explaining the use and how to utilize, partnerships to advance health initiatives.</p> <p>Back-to-School Health flyers and how to protect from mosquito borne illnesses awareness flyers were previously shared through email in Spanish, Creole, and English. Additionally, a reminder was shared that we are still in Hurricane season.</p>	
<p>Children Issues / Healthy Baby Taskforce Updates</p>	<p>Candice Schottenloher shared an update on the Children Issues / Healthy Baby Taskforce which tackled the Workplan topics.</p> <ul style="list-style-type: none"> <li>• The Children Issue &amp; Healthy Baby Taskforce in collaboration with Kendall Baptist Hospital have been working on swim safety initiatives. Baptist Hospital was able to have their Splash Day event back in May 2024, there were approximately 300 attendees, and 2,400 partners participated with educational materials. This helped tackle the Children Issues Committee workplan on sun and swim Safety.</li> <li>• New Swim Lesson Voucher program, Senate Bill 544, approved by the Governor this year. This program will be implemented through the Florida Department of Health. We are awaiting updates on the final logistics, eligibility, and who will be working on distributing vouchers. This took effect July 1, 2024. More information forthcoming.</li> <li>• Healthy Baby Taskforce has been working alongside the Jasmine Project to decrease infant mortality. There is a higher rate among the non-Hispanic black population for infants’ mortality, the focus is to close the gap by collaborating to tackle their workplans.</li> <li>• Healthy Corner Store Initiative: Healthy Baby Taskforce is launching a business wallet card and palm card. These would highlight nutrition and the importance of breastfeeding and how to increase the rates of mothers who breastfeed.</li> </ul>

- **Dream in Green**
- Our Committee Chair, Barbara Martinez Guerrero was able to attend event on Feeding South Florida at Miami-Dade Wolfson Campus. Various panelists present at the townhall, among which was a representative from the Miami-Dade County Public Schools for the food and nutrition. Last year they did a pilot program that consisted in placing 8 food pantries in different public schools, with the idea to engage in the future by adding more food pantries in more schools. The Miami-Dade Public Schools are trying to tackle the issue of food waste, it has been found that there is a high rate of food waste in cafeterias, it is one of the biggest ways to solve climate change. Share tables are being implemented in a lot of the public schools, they are working on placing small refrigerators to store milk and juice. They are connecting with Food Rescue with Feeding South Florida to collect the extra materials for food pantries.
- **Healthy Little Havana**
- Raissa Fernandez with HLH has shared a new community research study where they are trying to form a Community Advisory Board, which will be and is recruiting community partners.
- Partnered with a group of medical residents taking climate leadership micro credit from FIU. The students took an 88-week course where they had to finish a local action project focused on climate. The project focused was on the trash and litter in public spaces in Little Havana. They were able to complete a sculpture at the local domino plaza that highlighted the issue between health, climate, and open spaces in the community.
- Healthy Little Havana is preparing for the Dia De Los Muertos event on November 2, 2024, in Little Havana that is held annually. IT was established in 2018 as a cultural festival. Flyer will be shared once received. Supporters, collaborators all welcome to attend.
